The Madison Parish Police Jury met in regular session and convened at the Courthouse Building, Tallulah, Louisiana on Monday, May 22, 2023, 4:00 p.m.

The program management costs are not included as part of the allocation as they are funded from a separate pot of money and paid at 100% by FEMA. Mr. Ogden led the discussion of garbage billing errors on Terral Farms water bills. Terral had been overcharged \$135 per month since 2018. Following a discussion of the matter, Mr. Hughes offered a motion, seconded by Mr. Wilson to give Terral a credit for only three years toward future billings. Mr. Epps requested to use the tractor dedicated for cutting the sewage plant to use for parish-wide cutting since one of Public Works machines were down. Moving forward Public Works will do all the mowing.

Ms. S. Hutchinson appeared before the jury to discuss her termination at Madison Parish Hospital. She was referred back to Madison Parish Hospital Service District Board.

Ms. T. Johnson of the Tourism office gave an update on a recent conference she attended. One of the items of interest was the status of broadband in the parish and the provider. Also, she gave an update on Juneteenth activities. One of the activities was an exhibit of inventions by black inventors. A contribution of \$500 was requested from the Parish to bring the exhibition to Tallulah. Mr. Hughes offered a motion, seconded by Mr. Wilson, to contribution the \$500 to bring the exhibit to Tallulah. A roll call vote resulted in the following:
